APPOINTMENT OF DELIMITATION
COMMISSION FOR THE DIVISION OF THE
TERRITORY OF SOUTH WEST AFRICA INTO
ELECTORAL DIVISIONS FOR THE ELECTION
OF MEMBERS OF THE LEGISLATIVE
ASSEMBLY OF THE WHITES

The Administrator-General has under section 6 of the Proclamation on the Representative Authority of the Whites Proclamation, 1980 (Proclamation AG. 12 of 1980), read with section 13 of the Proclamation on Voters' Lists for Representative Authorities, 1980 (Proclamation AG. 22 of 1980), appointed the Honourable Mr Justus Frans Hendrik Badenhorst, Judge President of the South West Africa division of the Supreme Court of South Africa with effect from 1 July 1980 as Commissioner to divide the said territory delimitate into eighteen electoral divisions for the election of members of the said Legislative Assembly.

Mnr. P. J. Keyser has been appointed Secretary of the Delimitation Commission.
