REGULASIES INSAKE RAADPLEGENDE KOMITEES IN KLEURLINGDORPE

Dit het die Administrateur-generaal behaag om ooreenkomstig die bevoegdheid hom verleen by artikel 4 van die Ordonnansie op die Instelling van Bestuursvorme in Kleurlingdorpe 1965 (Ordonnansie 34 van 1965), saamgelees met die toepaslike bepalings van die Proklamasie op die Oordrag van Uitvoerende Gesag, 1977 (Proklamasie No. AG. 3 van 1977), soos gewysig, die Regulasies insake Raadplegende Komitees in Kleurlingdorpe soos afgekondig by Goewermentskennisgewing 151 (S.W.A.) van 15 Augustus 1966, te wysig soos uiteengesit in die Bylae hiervan.

BYLAE

Regulasie 14 word hierby gewysig deur —

- (a) in sub-regulasie (1) (i) die woorde *agenda-, spesiale- of* in te voeg na die woord *agtereenvolgende* waar dit daarin voorkom; en
- (b) 'n nuwe sub-regulasie (k) in te voeg na sub-regulasie (j), naamlik:
 - (k) 'n lid vir meer as drie maande agterstallig is met die betaling van enige munisipale rekenings wat deur hom verskuldig is.

REGULATIONS RELATING TO CONSULTATIVE COMMITTEES IN COLOURED TOWNSHIPS

The Administrator-General has been pleased in terms of the powers vested in him by section 4 of the Establishment of Local Government in Coloured Townships Ordinance, 1965 (Ordinance No. 34 of 1965), read with the appropriate provisions of the Executive Powers Transfer Proclamation, 1977 (Proclamation No. AG. 3 of 1977), as amended, to amend the Regulations Relating to Consultative Committees in Coloured Townships as published by Government Notice No. 151 of 1966 (S.W.A.) as set forth in the annexure hereto.

ANNEXURE

Regulation 14 is amended herewith by —

- (a) the insertion of the words: *agenda, special, or* after the word *consecutive* where it appears in sub-regulation (1) (i); and
- (b) the insertion of a new sub-regulation (k) after sub-regulation (j) viz:
 - (k) *a member who is in arrear with the payment of any municipal accounts due by him for more than three months.*

FOR CATCHING PELAGIC FISH

Under the powers vested in me by section 10(1)(a) of the Sea Fisheries Act (Act 58 of 1973) I hereby amend the regulations promulgated by Government Notice No. 1912 of 12 October 1973 (as amended) by inserting the following regulation No. 21 —

No. person shall in any way or for any purpose whatever, catch, attempt to catch or disturb any pelagic fish within the sea area bounded by a line (270° true) from Palgrave Point and a similar line opposite the mouth of the Kunene River unless he is in possession of a special permit issued by the Director.
