Under the powers vested in me by section 11 of the Voters' Lists for Legislative Authorities Proclamation, 1980 (Proclamation AG. 22 of 1980), every electoral division referred to in Annexure 3 of the Schedule to Proclamation AG. 45 of 1980, in respect of which polling districts are mentioned in that Annexure, is hereby subdivided into the polling districts so mentioned and to any such polling district the number mentioned in respect thereof in the said Annexure is hereby assigned.
