Kragtens die bevoegdheid my verleen by artikel 3 van die Wet op Pensioene vir Statutêre Instellings, 1980 (Wet 3 van 1980), verklaar ek hierby die Akademie vir Tersiêre Onderwys in artikel 2(1) van die Wet op die Akademie vir Tersiêre Onderwys, 1980 (Wet 13 van 1980), bedoel 'n statutêre instelling vir die doeleindes van eersgenoemde Wet met ingang van 1 September 1980.

Under the powers vested in me by section 3 of the Statutory Institutions Pensions Act, 1980 (Act 3 of 1980), I hereby declare the Academy for Tertiary Education referred to in section 2(1) of the Academy for Tertiary Education Act, 1980 (Act 13 of 1980), to be a statutory institution for the purposes of the first-mentioned Act, with effect from 1 September 1980.
