Van 'n punt (A op sketskaart P984) op grootpad 64 op die plaas Kohero 113 algemeen noordnoordooswaarts oor die plase Kohero 113 en Otjumue Süd 110 tot op 'n punt (B₁ op sketskaart P984) op die gemeenskaplike grens van die plase Otjumue Süd 110 en Otjumue 109 (A-B-B₁ op sketskaart P984).

Omaruru closed a portion of farm road 2308 which is indicated on sketch-map P984 as described in the Schedule hereunder.

The said sketch-map is lying open to inspection during normal office hours at the office of the Secretary of Transport, Windhoek.

DESCRIPTION OF ROAD

The road described as farm road 2308 in Schedule II of Proclamation 6 of 1963.

PORTION CLOSED

From a point (A on sketch-map P984) on main road 64 on the farm Kohero 113 generally north-north-eastwards across the farm Kohero 113 and Otjumue Süd 110 to a point (B₁ on sketch-map P984) on the mutual boundary of the farms Otjumue Süd 110 and Otjumue 109 (A-B-B₁ on sketch-map P984).
