The Administrator General has under section 32(4) of the Natives (Urban Areas) Proclamation, 1951 (Proclamation 56 of 1951), read with section 3 of the South West Africa Native Affairs Administration Act, 1954 (Act 56 of 1954), and section 2 of Executive Powers Transfer Proclamation, 1977 (Proclamation AG 3 of 1977), approved the amendment of the Native Location Regulations adopted by the Village Management Board of Bethanie and set out in schedule.
