It is hereby made known for general information —

(a) that the seats of those members of the Legislative Assembly of the Damaras who have in terms of subsection (1)(b) of section 34 of the Party List Elections Proclamation, 1980 (Proclamation AG. 54 of 1980) been declared to be duly elected members thereof and who are mentioned in Schedule 1, have become vacant before they have taken the prescribed oath of office; and
