## AMENDMENT OF THE MODEL STAFF REGULATIONS AS APPLIED TO THE MUNICIPALITY OF KEETMANSHOOP

The Executive Committee of the Whites has under section 243 of the Municipal Ordinance, 1963 (Ordinance 13 of 1963), approved the regulations set out in the Schedule and made by the Municipality of Keetmanshoop to effect a further amendment to the Model Staff Regulations, promulgated by Government Notice 119 of 2 October 1969 and amended by Government Notices 10 of 1970, 38 and 162 of 1971, 225 of 1973, 128 of 1977 and 128 of 1980, and, in respect of the said Municipality, applied by Government Notice 43 of 1 May 1971 and amended by Government Notices 182 of 1972, 253 of 1976 and 194 of 1979.

### SCHEDULE

1. Regulation 1 is hereby amended by the deletion in the definition of "employee" of the word "white".
2. Regulation 2 is hereby amended —
  - (a) by the deletion of paragraphs (c) and (e) of subregulation (1); and
  - (b) by the insertion in subregulation (5), after the word "shall", of the expression", if he qualifies,".
3. The following regulation is hereby substituted for regulation 11:
 

"11. Any employee who arrives late at work may be prohibited from beginning with his work and compelled to submit an application for leave in respect of the day concerned."
4. Regulation 12 is hereby amended —
  - (a) by the deletion in subregulation (2) of the expression "(4) and"; and
  - (b) by the substitution for the proviso to the said subregulation of the following proviso:
 

"Provided that any employee found guilty of misconduct may be dismissed summarily."
5. Regulation 14 is hereby amended by the deletion in subregulation (1) of the words "classes of".
