Amendment of regulation 48 of the regulations published by Government Notice R.550 of 1960

Regulation 48 of the regulations published by Government Notice R.550 of 14 April 1960 is hereby amended by the substitution for paragraph (g) of sub-regulation (2) of the following paragraph:

BYLAE

Wysigang van regulasie 48 van die regulasies afgekondig by Goewermentskennisgewing R.550 van 1960

Regulasie 48 van die regulasies afgekondig by Goewermentskennisgewing R.550 van 14 April 1960 word hierby gewysig deur paragraaf (g) van sub-regulasie (2) deur die volgende te vervang:

"Cash in, and insurance value of, insured parcels

"Kontant in, en versekeringswaarde van. versekerde pakkette

(g) (i) No insured parcel shall, without an authorisation in writing of the Postmaster-General, shall contain cash in excess of R1 110,75.

(g) (i) Geen versekerde pakket mag sonder die skriftelike magtiging van die Posmeester-generaal meer as R1 110,75 aan kontant bevat nie.

(ii) All parcels tendered for insurance shall be insured for the full value of the contents thereof to a maximum of R1 110,75."

(ii) Alle pakkette wat vir versekering aangebied word, moet vir die volle waarde van die inhoud daarvan tot 'n maksimum van R1 110,75, verseker word."
