Amendment of section 14 of Proclamation AG. 50 of 1980

1. Section 14 of the Representative Authority of the Hereros Proclamation, 1980, is hereby amended by the

"(1) Every session of the Assembly —"

- (a) shall be held at the seat of the Representative Authority or such other place as the Assembly may with the approval of the Administrator-General previously obtained and communicated to the Assembly determine either generally or specifically in respect of any particular session; and
- (b) shall commence and end on the respective dates determined by the Executive Committee with due regard to the provisions of section 13 of this Proclamation and section 11(1) of the principal Proclamation."

Short title

2. This Proclamation shall be called the Representative Authority of the Hereros Amendment Proclamation, 1981.

THE HEREROS AMENDMENT PROCLAMATION AS A SUBSIDIARY PROCLAMATION

WHEREAS it is expedient so to do in the public interest;

THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA, by virtue of the powers given to it in section 11(1) of the Constitution of the Republic of South Africa, 1984, and in accordance with the provisions of section 13 of this Proclamation, hereby amends the Proclamation of the Representative Authority of the Hereros, 1981, as follows:

SECTION 1.—(1) In section 1(1) of the Proclamation of the Representative Authority of the Hereros, 1981, as aforesaid, the words "Assembly" and "Administrator-General" shall be substituted for the words "Vergadering" and "Administrateur-General".

SECTION 2.—(1) Every session of the Assembly —
