APPROPRIATION ORDINANCE 1981

ORDINANCE

To appropriate an amount of money for the administration of the affairs of the Namas during the financial year ending 31 March 1982.

BE IT ORDAINED by the Legislative Assembly of the Namas as follows:

Appropriation of R8 731 000 for administration of affairs of Namas.

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act 66 of 1975), and the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), the amounts of money set out in column 1 of the Schedule is hereby appropriated, as a charge to the Revenue Fund of the Representative Authority of the Namas, for the administration of the affairs of the Namas during the financial year ending 31 March 1982.

Short title.

2. This Ordinance shall be called the Appropriation Ordinance, 1981.
