**Ordinance No. 2 APPROPRIATION ORDINANCE 1981**

**ORDINANCE**

**To appropriate an amount of money for the administration of the affairs of the Herero's during the financial year ending 31 March 1982.**

**BE IT ORDAINED** by the Legislative Assembly of the Herero's as follows:

Appropriation of R29 390 000 for administration of affairs of Herero's.

1. Subject to the provisions of the Exchequer and Audit Act, 1975 (Act 66 of 1975), and the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), the amount of money set out in column 1 of the Schedule is hereby appropriated, as a charge to the Revenue Fund of the Representative Authority of the Herero's, for the administration of the affairs of the Herero's during the financial year ending 31 March 1982.

Short title.

2. This Ordinance shall be called the Appropriation Ordinance, 1981.
