NOTICE is hereby given in terms of Section 25(6) of the Insurance Act, No. 27 of 1943 (as amended), that it is the intention of SANTAM INSURANCE LIMITED to transfer its insurance business carried on in the Republic of South Africa and the Territory of South West Africa to ASSURA LIMITED

The effect of the proposed transfer will be that ASSURA LIMITED will become responsible for the due fulfilment of the existing obligations of SANTAM INSURANCE LIMITED insofar as its insurance business in the Republic of South Africa and the Territory of South West Africa is concerned.

Details of the proposed transfer are contained in an agreement dated 18th August 1981, a copy of which, together with copies of statements showing the effect of the proposed transfer on the financial position of the parties to the agreement, will lie open for inspection by any person during normal business hours for a period of twenty-one (21) days commencing on 31st August 1981 to 21st September 1981 at the Head Office of SANTAM INSURANCE LIMITED, Corner Burg and Castle Streets, Cape Town and at the Head Office of ASSURA LIMITED, Corner Burg and Castle Streets, Cape Town.

OORDRAG VAN VERSEKERINGSBESIGHEID NA ASSURA BEPERK
