ANNOUNCEMENT OF SPECIAL GENERAL ELECTION OF MEMBERS OF THE LEGISLATIVE ASSEMBLY OF THE DAMARAS

I hereby make known for general information that a general election of members of the Legislative Assembly of the Damaras is, in terms of section 2(1) of the Legislative Assembly of the Damaras Special General Election Proclamation, 1982, to be held within six months after the commencement of the said Proclamation and that the said election is in terms of section 2(2) of the said Proclamation to be conducted *mutatis mutandis*

genoemde Proklamasie *mutatis mutandis* kragtens die Partylysverkiegingsproklamasie, 1980, gevoer word.

Ingevolge artikel 3 van genoemde Partylysverkiegingsproklamasie, 1980, bepaal ek dan hierby —

- (a) dat 'n registrasiehof op 29 Oktober 1982 in die Raadsaal, Administratiewe Kantore van die Administrasie vir Damaras, Khorixas, sitting sal hou om die registrasiestukke te ontvang van enige politieke organisasie wat deur middel van 'n lys van kandidate aan bedoelde verkiesing wil deelneem en nie reeds voor daardie datum ooreenkomstig artikel 4 van laasgenoemde Proklamasie vir bedoelde verkiesing geregistreer het nie;
- (b) dat, indien 'n stemming ingevolge artikel 6(11) van laasgenoemde Proklamasie nodig word omdat daar by die einde van die sitting van die registrasiehof meer as een politieke organisasie vir die verkiesing geregistreer het, die stemming ten opsigte van die verkiesing op 1, 2 en 3 Desember 1982 sal plaasvind en dat die stemming ingevolge artikel 17 van laasgenoemde Proklamasie op elk van daardie dae om sewe-uur in die oggend sal begin en om sewe-uur in die aand sal sluit, maar dat die voorsittende beampte by 'n stemburo ingevolge genoemde artikel 17 die stemming by daardie stemburo op 1 en 2 Desember 1982 later as sewe-uur in die aand kan sluit.

Hierby word voorts vir algemene inligting bekend gemaak dat, ooreenkomstig artikel 6(2) en (4) van laasgenoemde Proklamasie, die sitting van die registrasiehof op 29 Oktober 1982 om nege-uur voormiddag sal begin en dat geen registrasiestukke ná eenuur daardie namiddag ontvang sal word nie, maar indien 'n verteenwoordiger van 'n politieke organisasie om eenuur daardie namiddag in die hof aanwesig is en gereed is om registrasiestukke ten opsigte van daardie politieke organisasie voor te lê, die voorsitter van die registrasiehof hom 'n geleentheid moet gee om dit te doen.

under the Party List Elections Proclamation, 1980.

In terms of section 3 of the said Party List Elections Proclamation, 1980, I therefore hereby determine —

- (a) that a registration court will sit on 29 October 1982 in the Conference Hall, Administrative Offices of the Administration for Damaras, Khorixas, to receive the registration documents of any political organization that desires to take part, by means of a list of candidates, in the said election and has not before that date already registered for the said election in accordance with the provisions of section 4 of the last-mentioned Proclamation;
- (b) that, if a poll becomes necessary in terms of section 6(11) of the last-mentioned Proclamation for the reason that at the end of the sitting of the registration court more than one political organization has registered for the election, the poll in respect of the election will take place on 1, 2 and 3 December 1982 and that the poll shall, in terms of section 17 of the last-mentioned Proclamation, on each of those days commence at seven o'clock in the morning and close at seven o'clock in the evening, but that the presiding officer at any polling station may, in terms of the said section 17, on 1 and 2 December 1982 close the poll at such polling station later than seven o'clock in the evening.

It is hereby furthermore made known for general information that, in accordance with the provisions of section 6(2) and (4) of the last-mentioned Proclamation, the sitting of the registration court on 29 October 1982 will commence at nine o'clock in the forenoon and that no registration documents will be received after one o'clock that afternoon, but if at one o'clock that afternoon any representative of any political organization is present in the court and ready to submit registration documents in respect of that political organization, the chairman of the registration court shall give him an opportunity to do so.
