## SCHEDULE

*Delegation of powers by Administrator-General*

I. (1) The Administrator-General may from  
time to time delegate to any person or persons  
designated by him any power vested in him under  
any law, other than any such power -

- (a) to issue or make proclamations, regulations  
or rules;

## BYLAE

*Delegering van bevoegdhede deur Administrateur-  
generaal*

I. (1) Die Administrateur-generaal kan enige  
bevoegdheid wat kragtens die een of ander wet by  
hom berus, behalwe enige sodanige bevoegdheid -

- (a) om proklamasies, regulasies of reëls uit te  
vaardig of te maak;

(a) to consent to the making of laws or to refuse such consent or to approve, or assent to, laws or to deal therewith in any other way;

(b) om toestemming tot die maak van wette te verleen of om sodanige toestemming te weier of om wette goed te keur of daarin toe te stem of andersins daarmee te handel;

(c) which has to be exercised by notice in the *Official Gazette*.

(c) wat by kennisgewing in die *Offisiële Koerant* uitgeoefen moet word,

van tyd tot tyd deleger aan 'n persoon of persone deur hom aangewys.

(2) Any person to whom any power has been delegated under subsection (1) shall exercise such power subject to the instructions of the Administrator-General.

(2) Iemand aan wie 'n bevoegdheid kragtens subartikel (1) gedeleger is, oefen daardie bevoegdheid uit onderworpe aan die voorskrifte van die Administrateur-generaal.

(3) The delegation of any power under subsection (1) shall not divest the Administrator-General of that power and the Administrator-General may at any time amend or withdraw any decision of any person in the exercise of any power so delegated to such person: Provided that such a withdrawal or amendment of any such decision shall not affect the validity of anything done under such a decision before the said withdrawal or amendment thereof.

(3) Die delegering van 'n bevoegdheid kragtens subartikel (1) ontdoen nie die Administrateur-generaal van daardie bevoegdheid nie en die Administrateur-generaal kan 'n beslissing van enige persoon by die uitoefening van 'n bevoegdheid aldus aan bedoelde persoon gedeleger te eniger tyd wysig of intrek: Met dien verstande dat die intrekking of wysiging aldus van so 'n beslissing nie die geldigheid van enigiets wat voor bedoelde intrekking of wysiging daarvan kragtens so 'n beslissing gedoen is, raak nie.

(4) Any decision of any person in the exercise of any power delegated to him under subsection (1) shall be deemed to be a decision of the Administrator-General unless such decision is withdrawn by the Administrator-General under subsection (3): Provided that if such a decision is amended by the Administrator-General under subsection (3), the said decision shall, subject to the provisions of the proviso to the said subsection (3), be deemed to be the decision of the Administrator-General as so amended by him.

(4) 'n Beslissing van enige persoon by die uitoefening van 'n bevoegdheid kragtens subartikel (1) aan hom gedeleger, word geag 'n beslissing van die Administrateur-generaal te wees tensy bedoelde beslissing deur die Administrateur-generaal ingetrek word kragtens subartikel (3): Met dien verstande dat indien so 'n beslissing deur die Administrateur-generaal gewysig word kragtens subartikel (3), bedoelde beslissing, behoudens die bepaling van die voorbehoudsbepaling by genoemde subartikel (3), geag word die beslissing van die Administrateur-generaal te wees soos aldus deur hom gewysig.

(5) The Administrator-General may at any time

(5) Die Administrateur-generaal kan te eniger tyd -

(a) withdraw any delegation of any power made under subsection (1);

(a) 'n delegering van 'n bevoegdheid wat kragtens subartikel (1) gedoen is, intrek;

(b) alter or withdraw the instructions referred to in subsection (2) to which the exercise of any power so delegated is subject.

(b) die in subartikel (2) bedoelde voorskrifte waaraan die uitoefening van 'n bevoegdheid wat aldus gedeleger is, onderworpe is, verander of intrek.

2. This Proclamation shall be called the Delegation of Powers Proclamation, 1983.
