BE IT ORDAINED by the Legislative Assembly of the  
Tswanas, as follows:-

Appropriation of R5  
755 070 for admini-  
stration of affairs of  
Tswanas.

**1.** Subject to the provisions of the Representative  
Authorities Proclamation, 1980 (Proclamation AG. 8 of  
1980), and the State Finance Act, 1982 (Act 1 of 1982), the  
amounts of money set out in column 1 of the Schedule are  
hereby appropriated, as a charge to the Revenue Fund of  
the Representative Authority of the Tswanas, for the ad-  
ministration of the affairs of the Tswanas during the finan-  
cial year ending 31 March 1984.

**2.** This Ordinance shall be called the Appropriation Or-  
dinance, 1983.
