REGULASIES KRAGTENS DIE WET OP
STATISTIEKE, 1976 (WET 66 VAN 1976) MET
BETREKKING TOT DIE VERSAMELING
VAN STATISTIEKE BETREFFENDE
ARBEIDSAANGELEENTHEDEREGULATIONS UNDER THE STATISTICS
ACT, 1976 (ACT 66 OF 1976) IN RELATION
TO THE COLLECTION OF STATISTICS
REGARDING LABOUR MATTERS

Die Administrateur-generaal het kragtens artikel 17 van die Wet op Statistieke, 1976 (Wet 66 van 1976) die regulasies wat in die Bylae vervat is, uitgevaardig.

The Administrator-General has, under section 17 of the Statistics Act, 1976 (Act 66 of 1976), made the regulations set out in the Schedule.

BYLAE

SCHEDULE

*Woordomsrywings**Definitions*

1. In hierdie regulasies, tensy uit die samehang anders blyk, het 'n uitdrukking wat in die Wet omskryf word 'n ooreenstemmende betekenis, en beteken -

1. In these regulations, unless the context otherwise indicates, an expression defined in the Act. has a corresponding meaning and -

- (ii) "employer" means any person whatsoever who employs or provides work for any person and who remunerates that person, or

- (ii) "die Wet" die Wet op Statistieke, 1976 (Wet 66 van 1976), soos gewysig; (iv)
- (iii) "werkgever" enige persoon hoegenaamd wat enige persoon in diens het of aan hom werk verskaf, en wat daardie persoon beloon, of uitdruklik of stilswyend onderneem om hom te beloon, of wat enige persoon hoegenaamd toelaat om hom op enige wyse te help om sy besigheid of boerdery voort te sit of te bedryf; (ii)
- (iv) "werknemer" ook enige persoon wat in diens is by of werk verrig vir, enige werkgever en beloning ontvang of geregtig is om dit te ontvang en enige ander persoon hoegenaamd wat enige werkgever op enige wyse help om sy besigheid of boerdery voort te sit of te bedryf. (i)

expressly or tacitly undertakes to remunerate him or who permits any person whatsoever in any manner to assist him in the carrying on or conducting of his business or farming operations; (iii)

- (iii) "remuneration" means any salary, wage, earning or compensation in money or in natura or both in money and in natura that is paid, made, handed over or owed to any person and that arises or results in any manner whatsoever out of the employment or work of such person to whom the salary, wage, earning or compensation is so due; and "remunerate" has a corresponding meaning; (i)
- (iv) "the Act" means the Statistics Act, 1976 (Act 66 of 1976), as amended. (ii)

Gegewens wat verstrekk moet word betreffende werkgewers, werknemers en ander arbeidsaangeleentehede

2. (1) Elke werkgever moet aan die Sekretaris die volgende statistieke verstrekk in die vorm wat deur die Sekretaris bepaal is -

- (a) sy naam en adres in die geval van 'n eenmansbesigheid;
- (b) die besighedsnaam en -adres in geval van ander besighede, bedrywe of organisasies;
- (c) die soort besigheid, bedryf of organisasie;
- (d) die hoof- en ander aktiwiteite van die besigheid, bedryf of organisasie;
- (e) die aantal werknemers in die besigheid, bedryf of organisasie, asook hulle beroepe;
- (f) enige tekort aan werknemers en in welke beroepsrigtings sodanige tekorte ondervind word;
- (g) die verwagte toename in die getal werknemers gedurende die tydperk in die vorm vermeld; en
- (h) die verwagte afname in die getal werknemers gedurende die tydperk in die vorm vermeld.

(2) Die in subregulasie (1) bedoelde bepalings is nie van toepassing nie op 'n persoon wat 'n ander persoon in verband met sy privaat huishouding in diens het.

Particulars to be furnished relating to employers, employees and other labour matters

2. (1) Every employer shall furnish the Secretary in the form determined by the Secretary with the following statistics -

- (a) his name and address in the case of a one man concern;
- (b) the name and address of the business in case of other businesses, trades or organisations;
- (c) the type of business, trade or organisation;
- (d) the main- and other activities of the business, trade or organisation;
- (e) the number of employees in the business, trade or organisation as well as their occupations;
- (f) any shortage of employees, and in which occupations such shortage is experienced;
- (g) the expected increase in the number of employees during the period mentioned in the form; and
- (h) the expected decrease in the number of employees during the period mentioned in the form.

(2) The provisions referred to in subregulation (1) are not applicable to a person who employs any other person in connection with his private household.

Plig om vorm in te vul of statistieke te verstrek

- (b) indien die betrokke werkgewer om die een of ander rede nie in staat is om bedoelde vorm in te vul of bedoelde statistieke te verstrek nie, deur die persoon in beheer van die grond, perseel, gebou of struktuur waarop of waarin die werkgewer op die bepaalde tydstip 'n werknemer of werknemers in diens het.

Die tye wanneer, die plekke waar en die adres of persone aan wie die ingevulde vorm oorhandig of statistieke verstrek moet word

4. Die in regulasie 3 bedoelde ingevulde vorm, of statistieke moet aan die Sekretaris oorhandig of, na gelang van die geval verstrek word voor of op 30 Julie 1984, by die adres op bedoelde vorm aangedui.

Misdrywe en strawwe

5. Enige persoon wat sonder redelike oorsaak enige bepaling van hierdie regulasies oortree of versuim om daaraan te voldoen is aan 'n misdryf skuldig en is by skuldigbevinding strafbaar -

- (a) met 'n boete van hoogstens tweehonderd rand; of
- (b) in die geval van 'n voortdurende versuim om daaraan te voldoen, met 'n boete van hoogstens tien rand vir elke dag waarop sodanige versuim aldus voortduur.

Duty to fill in form or to furnish statistics

3. The form referred to in regulation 2 shall duly be filled in or, when so requested by the Secretary, the statistics referred to in regulation 2 shall be furnished orally -

- (a) by the employer concerned; or
- (b) if the employer concerned is for any reason unable to fill in the said form or to furnish the said statistics, by the person in control of the land, premises, building or structure whereon or wherein the employer employs an employee or employees at the relevant time.

The times when, the places where and the address or the persons to whom the completed form shall be handed over or statistics shall be furnished

4. The completed form or statistics referred to in regulation 3 shall be handed over or, as the case may be, be furnished to the Secretary at the address indicated on the said form before or on 30 July 1984.

Offences and penalties

5. Any person who, without reasonable cause, contravenes or fails to comply with any provision of these regulations shall be guilty of an offence and liable on conviction -

- (a) to a fine not exceeding two hundred rand; or
- (b) in the case of a continuing failure to comply therewith, to a fine not exceeding ten rand for every day during which such failure so continues.
