2. Regulation 13 is hereby amended by the addition thereto of the following paragraphs, the existing regulation becoming paragraph (a):

"(b) The occupier of any dwelling or public building shall place in each receptacle provided by him, a bag in such a manner that domestic refuse can be dumped directly therein.

(c) The occupier of any dwelling or public building shall ensure that each full bag which is removed from the receptacle is properly tied up and be placed on the pavement on the days from time to time determined by the Board for removals.”.

**3. Schedule A is hereby amended -**

- (a) by the substitution in item (2) for the amount “R4,00” of the amount “R4,50”; and  
 (b) by the substitution in item (4) for the amount “R5,00” of the amount “R7,50”.
