## ADDITIONAL APPROPRIATION ORDINANCE

(Assented to by the Administrator-General on 28 March 1985)

## ORDINANCE

To appropriate an additional amount of money for the affairs of the Hereros during the financial year ending 31 March 1985.

BE IT ORDAINED by the Legislative Assembly of the Hereros, as follows:-

Appropriation of additional amount of R5 486 960 for administration of affairs of Hereros.

1. Subject to the provisions of the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), and the State Finance Act, 1982 (Act 1 of 1982), the additional amounts of money set out in the Schedule are hereby appropriated, as a charge to the Revenue Fund of the Representative Authority of the Hereros, for the administration of the affairs of the Hereros during the financial year ending 31 March 1985.

Short title.

This Ordinance shall be called the Additional Appropriation Ordinance, 1985.
