AFKONDIGING VAN WET NA NASIONALE

The following Act, which has been adopted by the National Assembly and signed by the Administrator-General in terms of the South West Africa Legislative and Executive Authority Establishment Proclamation, 1985 (Proclamation R.101 of 1985), is hereby published in terms of section 18 of that Proclamation: —

Act No. 6, 1985

COPYRIGHT AMENDMENT ACT, 1985

(English text signed by the Administrator-General on 20 August 1985)

ACT

To amend the Copyright Act, 1965, so as to regulate the copyright in certain broadcasts made by the South West African Broadcasting Corporation.

BE IT ENACTED by the National Assembly, as follows:-

Amendment of section 1 of Act 63 of 1965.

1. Section 1 of the Copyright Act, 1965, is hereby amended by the substitution for the definition of "Corporation" of the following definition:

" 'Corporation' means the South West African Broadcasting Corporation established by the Broadcasting Act Amendment Proclamation, 1979 (Proclamation AG. 16 of 1979);".

Short title and commencement.

2. This Act shall be called the Copyright Amendment Act, 1985, and shall be deemed to have come into operation on 1 May 1979.

Tot wysiging van die Wet op Outeursreg, 1965, ten einde die outeursreg in sekere uitsendings deur die Suidwes-Afrikaanse Uitsaaikorporasie te reël.

DAAR WORD BEPAAL deur die Nasionale Vergadering, soos volg:-

1. Artikel 1 van die Wet op Outeursreg, 1965, word hierby gewysig deur die omskrywing van "Korporasie" deur die volgende omskrywing te vervang:

Wysiging van artikel 1 van Wet 63 van 1965.

“ ‘Korporasie’ die Suidwes-Afrikaanse Uitsaaikorporasie ingestel deur die Wysigingsproklamasie op die Uitsaaiwet, 1979 (Proklamasie AG. 16 van 1979);”.

2. Hierdie Wet heet die Wysigingswet op Outeursreg, 1985, en word geag op 1 Mei 1979 in werking te getree het.
