DEVIATION OF A PORTION OF FARM

In terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Minister of Transportation has under section 22(1)(c) of the said Ordinance, in the district of Gobabis, deviated the portion of farm road 1642 described in paragraph (a) of the Schedule and shown on sketch-map P1303 by the symbols A – C, from the route so described and shown, to the route described in paragraph (b) of the Schedule and shown on sketchmap P1303 by the symbols A-B.
