- VARIATION OF CONDITIONS OF ESTABLISHMENT: SWAKOPMUND (EXTENSION 6)

In terms of paragraph (b) of the proviso to section 31A(2) of the Townships and Division of Land Ordinance, 1963 (Ordinance 11 of 1963), I hereby make known that I have under the said section 31A(2) of the said Ordinance varied the conditions set forth in the Schedule to Proclamation 58 of 1970 as set out in the Schedule hereunder.

BYLAE

1. Paragraaf 6 word hierby gewysig deur in die opskrif daarvan die nommer "1276" deur die nommer "1277" te vervang.
2. Die volgende paragraaf word hierby na paragraaf 7 ingevoeg:
 "7A Bykomende voorwaardes ten opsigte van erf 1276.
 (1) Die erf mag slegs vir woondoeleindes gebruik word, met inbegrip vir die oprigting van 'n blok woonstelle.
 (2) As 'n blok woonstelle op die erf opgerig word, moet minstens 1 onafhanklike parkeerplek op die erf vir elke woonsteleenhed voorsien word, en minstens 1 onafhanklike parkeerplek van die straat af op die erf vir elke 4 woonsteleenhede voorsien word.
 (3) Die oppervlakte gedek deur die geboue, opgerig op die erf, mag nie 40% van die totale oppervlakte van die erf oorskry nie.
 (4) Die eienaar van die erf is verplig om, sonder vergoeding en ten genoë van die plaaslike bestuur, die geboue op die erf opgerig, insluitende die buitegeboue wat deur die bediendes wat hul dienste op die erf verrig, bewoon word, te verbind met die openbare waternetwerk- en rioolverwyderingstelsel.
 (5) Die waarde van die hoofgebou, buitegeboue uitgesluit, mag in die geval van 'n enkelwoonhuis, nie minder as R60 000,00 wees nie, en, in die geval van dupekswoonstelle of 'n woonstelblok, nie minder as R100 000,00 wees nie."

VERKLARING VAN WANAHEDA (UITBREIDING 7) TOT GOEDGEKEURDE DORP

Kragtens artikel 13 van die Ordonnansie op Dorpe en Grondverdeling 1963 (Ordonnansie 11

SCHEDULE

1. Paragraph 6 is hereby amended by the substitution in the heading thereof for the number "1276" of the number "1277".
2. The following paragraph is hereby inserted after paragraph 7:
 "7A Additional conditions applicable to erf 1276.
 (1) The erf may be used only for residential purposes, including for the erection of a block of flats.
 (2) Should a block of flats be erected on the erf, at least 1 independent parking bay shall be provided on the erf for every flat unit and at least 1 independent off-street parking space on the erf for every 4 flat units.
 (3) The area covered by the buildings erected on the erf shall not exceed 40% of the total area of the erf.
 (4) The owner of the erf shall be obliged, without compensation and to the satisfaction of the local authority, to connect the buildings erected on the erf, including the outbuildings occupied by the servants who render their services on the erf, to the public water reticulation and sewerage disposal system.
 (5) The value of the main building, excluding outbuildings, shall, in the case of a single dwelling, be not less than R60 000,00, and, in the case of duplex flats or a block of flats, be not less than R100 000,00."

DECLARATION OF WANAHEDA (EXTENSION 7) TO BE AN APPROVED TOWNSHIP

Under section 13 of the Townships and Division of Land Ordinance, 1963 (Ordinance 11 of 1963),

van 1963) verklaar ek hierby die gebied voorgestel op Algemene Plan K. 218(A.588/87) tot goed-gekeurde dorp.

Die voorwaardes ingevolge waarvan die aansoek om verlof tot stigting van die betrokke dorp toegestaan is, word ingevolge genoemde artikel 13 in die Bylae hieronder uiteengesit.

BYLAE

1. NAAM VAN DORP

Die dorp heet Wanaheda (Uitbreiding 7).

2. SAMESTELLING VAN DORP

Die dorp bestaan uit 434 erwe genummer 1741 tot 2174, 6 oop ruimtes genummer 2175 tot 2180 en strate soos aangedui op Algemene Plan K. 218(A.588/87).

3. TITELVOORWAARDES

Die volgende voorwaardes moet ten gunste van die plaaslike bestuur geregistreer word teen die titelbewyse van alle erwe:

(1) Die erf mag benut of geokkupeer word slegs vir doeleindes wat strook met, en die benutting of okkupasie van die erf sal te alle tye onderworpe wees aan, die bepalinge van die Dorpsbeplanningskema van Windhoek wat ingevolge die Dorpsbeplanningsordonnansie 1954 (Ordonnansie 18 van 1954) ontwerp en goedgekeur is.

(2) Geen boom bekend as Prosopis SSP mag op die erf geplant of toegelaat word om daarop te groei nie.

I hereby declare the area represented by General Plan K. 218(A.588/87) to be an approved township.

The conditions subject to which the application for permission to establish the township concerned has been granted, are set forth in the Schedule below in terms of the said section 13.

SCHEDULE

1. NAME OF TOWNSHIP

The township shall be called Wanaheda (Extension 7).

2. COMPOSITION OF TOWNSHIP

The township comprises 434 erven numbered 1741 to 2174, 6 open spaces numbered 2175 to 2180 and streets as indicated on General Plan K. 218(A.588/87).

3. CONDITIONS OF TITLE

The following conditions shall be registered in favour of the local authority against the title deeds of all erven:

(1) The erf shall be used or occupied only for purposes which are in accordance with, and the use or occupation of the erf shall at all times be subject to, the provisions of the Windhoek Town Planning Scheme prepared and approved in terms of the Town Planning Ordinance, 1954 (Ordinance 18 of 1954).

(2) No tree known as Prosopis SSP shall be planted or permitted to grow on the erf.

(a) in kolom 2 van die Bylae die omskrywing van die gebied "Gobabis" deur die volgende omskrywing te vervang:

"Die Landdrosdistrik Gobabis soos omskryf in Bylae J by Goewermentskennisgewing 1148 (Republiek) gepubliseer in Staatskoerant 3598 van 30 Junie 1972, met inbegrip van Gebiede 2 en 3 van Hereroland-Oos omskryf in Bylae E by Goewermentskennisgewing 2428 van 1972, soos gewysig by Goewermentskennisgewing 322 van 1976, maar uitgesonderd daardie gebiede in genoemde distrik wat geleë is binne die regsgebiede van die plaaslike besture vir Gobabis, Leonardville en Witvlei.", en

(b) in kolom 2 van die Bylae in die omskrywing van die gebied "Kamanjab" na die uitdrukking "3598 van 30 Junie 1972," die uitdrukking "met inbegrip van die gebied omskryf as Gebied 1 in Bylae A by Goewermentskennisgewing 2428 van 1972, maar" in te voeg.

1. Proclamation 1 of 1973 is hereby amended by -

(a) the substitution in column 2 of the Schedule for the definition of the area of "Gobabis" of the following definition:

"The magisterial district of Gobabis as described in Schedule J to Government Notice 1148 (Republic) as published in Government Gazette 3598 of 30 June 1972, including Areas 2 and 3 of Hereroland East described in Schedule E to Government Notice 2428 of 1972, as amended by Government Notice 322 of 1976, but excluding those areas in the said magisterial district that are situated within the areas of jurisdiction of the local authorities for Gobabis, Leonardville and Witvlei."; and

(b) the insertion in column 2 of the Schedule in the definition of the area of "Kamanjab" after the expression "3598 of 30 June 1972," the expression "including the area described as Area 1 in Schedule A to Government Notice 2428 of 1972, but".

2. Proclamation AG. 26 of 1982 is hereby amended by the substitution in column 2 of the Schedule for the definition of the area of "Hereroland" of the following definition:

- (a) in Bylae B by Goewermentskennisgewing 1196 van 1970; en
 - (b) as Gebied 1 in Bylae E by Goewermentskennisgewing 2428 van 1972, soos gewysig by Goewermentskennisgewing 322 van 1976.”.
