No. 1 of 1988***(Assented to by the Administrator-General on

To appropriate an additional amount of money for the administration of the affairs of the Damaras during the financial year ending 31 March 1988.

BE IT ORDAINED by the Legislative Assembly of the Damaras, as follows:

1. Subject to the provisions of the Representative Authorities Proclamation, 1980 (Proclamation AG. 8 of 1980), the additional amounts of money set out in the Schedule are hereby appropriated as a charge to the Revenue Fund of the Representative Authority of the Damaras, for the administration of the affairs of the Damaras during the financial year ending 31 March 1988.

Appropriation of additional amount of R3 282 754 for administration of affairs of Damaras.

2. This Ordinance shall be called the Additional Appropriation Ordinance (1987/88), 1988.
