ACT

To amend the Amortization Fund of South West Africa Act, 1987, so as to renumber a certain section and certain references; and to provide for incidental matters.

*(Afrikaans text signed by the Administrator-General
on 8 June 1988)*

BE IT ENACTED by the National Assembly, as follows:-

1. Section 2 of the Amortization Fund of South West Africa Act, 1987 (hereinafter referred to as the principal Act), is hereby amended by the substitution for the number "2.(1)" of the number "2".

2. Section 4 of the principal Act is hereby amended —

(a) by the substitution in paragraph (a) of subsection (1) for the number "2(1)" of the number "2"; and

(b) by the substitution in paragraph (b) of the said subsection (1) for the number "2(2)" of the number "3".

3. This Act shall be called the Amortization Fund of South West Africa Amendment Act, 1988.
