OFFICIAL GAZETTE OF SOUTH WEST AFRICA**

**PROSEDURE VIR ADVERTENSIES IN DIE OFFISIËLE  
KOERANT VAN SUIDWES-AFRIKA**

1. The *Official Gazette* Extraordinary containing advertisements, is published on every Friday. If a Friday falls on a Public Holiday, the *Official Gazette* is published on the preceding Thursday.

1. Die Buitengewone *Offisiële Koerant* wat advertensies bevat, verskyn elke Vrydag. Indien 'n Vrydag op 'n Openbare Feesdag val, verskyn die *Offisiële Koerant* op die voorafgaande Donderdag.

2.
