- (ii) installing, repairing and maintaining existing and new telephone switch-boards and apparatus, telex machines, facsimile machines and the necessary lines for such apparatus and machines and data and computer lines in buildings,

if such service cannot properly be performed without infringing such provisions;

(b) I hereby further amend -

- (i) Government Notice 85 of 1974 by the deletion in the Schedule of paragraph 1;
- (ii) Government Notice 171 of 1974 by the deletion in the Schedule of paragraph 1; and
- (iii) Government Notice 215 of 1976 by the deletion in the Schedule of paragraph 1; and
