1. Section 1 of the Road Transportation Act, 1977 (hereinafter referred to as the Act), is hereby amended –

- (a) by the deletion in subsection (1) of the definition of “Administrator”;
- (b) by the deletion in subsection (1) in the definition of “authorised officer” of the words “any member of the South African Railways Police Force in respect of any place whether within or beyond the limits of the railways as defined in section 1 of the South African Transport Services Act, 1981 (Act No. 65 of 1981), or of the harbours as defined in the said section”;
- (c) by the substitution in subsection (1) for the definition of “board” of the following definition:

“‘board’ means the Road Transportation Board of South West Africa established by section 4;”;

- (d) by the substitution in subsection (1) for the definition of “commission” of the following definition:

“‘commission’ means the Road Transportation Commission of South West Africa established by section 2A;”;

- (e) by the deletion in subsection (1) of the definition of “competent board”;
- (f) by the substitution in subsection (1) for the definition of “local authority” of the following definition:

“‘local authority’ means a municipality established under the Municipal

- (j) by the deletion in subsection (1) of the definition of “Republic”;
- (k) by the addition in subsection (1) in the definition of “road transportation” after paragraph (d) of the following paragraph:
 - (e) in the case of persons or goods which are conveyed from any neighbouring country, including the Republic of South Africa or Walvis Bay, outside the Territory to or through the Territory, the conveyance as referred to in paragraph (a), (b), (c) or (d) from any point on a public road on the border between the Territory and any such neighbouring country, including the Republic of South Africa or Walvis Bay, to any place in the Territory or through the Territory to any or the same point on any such border;”;
- (l) by the deletion in subsection (1) of the definition of “transportation area”;

- “(r) the conveyance by TransNamib Limited, by means of a motor vehicle of which it is the owner, of its employees or goods in the course of its business and otherwise than for reward, and of goods within its area of jurisdiction as defined in section 1 of the National Transport Co-operation Act, 1987 (Act No. 21 of 1987);”;
- (q) by the substitution for paragraph (z) of subsection (2) of the following paragraph:
- “(z) the conveyance in the manner and on the conditions prescribed by regulation of exempted goods, by means of a motor vehicle –
- (i) which is registered in the Territory under the law governing the registration of motor vehicles in the Territory;

 - (iii) which is identified in the manner prescribed by regulation,
- by any person who is domiciled in the Territory, or any company registered in the Territory, actively carrying on business from a place situated in the Territory;”; and

Amendment of section 2 of Act 74 of 1977, as amended by section 2 of Proclamation AG. 33 of 1985 and section 1 of Act 20 of 1988

2. (1) Section 2 of the Act is hereby amended –

- (a) by the substitution for the word "Cabinet" and the word "Gazette", wherever it occurs, of the word "Administrator-General" and the words "Official Gazette", respectively;
- (b) by the deletion of paragraph (a);
- (c) by the deletion in paragraph (e)*bis* of the words "commission and any competent"; and
- (d) by the addition of the following subsection, the existing section becoming subsection (1):

"(2) A notice issued under paragraph (e)*bis* of subsection (1), shall, notwithstanding anything to the contrary contained in any law or the common law, apply also in relation to any application received before the date of the notice in question, but has not yet been granted. "

(2) Paragraph (d) of subsection (1) shall be deemed to have come into operation on 30 December 1988.

Insertion of section 2A in Act 74 of 1977

3. The following section is hereby inserted in the Act after section 2:

"Establishment and constitution of Road Transportation Commission of South West Africa."

2A.(1) There is hereby established a commission to be called the Road Transportation Commission of South West Africa.

Invoeging van artikel 2A in Wet 74 van 1977

3. Die volgende artikel word hierby in die Wet na artikel 2 ingevoeg:

"Instelling en samestelling van Padvervoerkommisie van Suidwes-Afrika."

2A. (1) Daar word hierby 'n kommissie met die naam die Padvervoerkommisie van Suidwes-Afrika ingestel.

(2) The commission shall consist of a chairman appointed by the Administrator-General who shall be an advocate or attorney who has practised in the law for a period of at least five years and at least two, but not more than four other persons so appointed who shall be persons who possess wide experience of, and have shown ability in connection with, transport, industrial, commercial or financial matters or in the conduct of public affairs and who is not a member of the board or is not a person referred to in paragraphs (a), (b), (c) and (d) of subsection (1) of section 5.

(3) A member of the commission shall vacate his office if –

- (a) he becomes subject to a disqualification referred to in paragraph (a), (b), (c) or (d) of subsection (1) of section 5;
- (b) he resigns by notice in writing addressed to the Administrator-General; or
- (c) he, in the opinion of the Administrator-General, is unable to perform efficiently his duties and he is removed by the Administrator-General from office.

(4) A member of the commission who is not full-time in the government service shall hold his office for a period of five years, but shall be eligible for re-appointment at the expiration of his period of office.

(5) A member of the commission who is not full-time in the government service shall receive such remuneration and allowances as may be determined by the Administrator-General.

(3) 'n Lid van die kommissie ontruim sy amp indien –

- (a) hy aan 'n onbevoegdheid bedoel in paragraaf (a), (b), (c) of (d) van subartikel (1) van artikel 5 onderworpe word;
- (b) hy deur skriftelike kennisgewing aan die Administrateur-generaal bedank; of
- (c) hy na die oordeel van die Administrateur-generaal nie in staat is om sy pligte as lid doeltreffend uit te voer nie en hy deur die Administrateur-generaal uit sy amp onthef word.

(4) 'n Lid van die kommissie wat nie heeltyds in die regeringsdiens is nie, beklee sy amp vir 'n tydperk van vyf jaar, maar kan by die verstryking van sy ampstermyn weer aangestel word.

(5) 'n Lid van die kommissie wat nie heeltyds in die regeringsdiens is nie, ontvang die besoldiging en toeslaes wat die Administrateur-generaal bepaal.

(6) Whenever a member of a commission has recused himself in any particular matter, the Administrator-General may appoint any person whom he considers suitable, to act with regard to the particular matter in place of that member, and any such appointment shall, in the case of a person who is not full-time in the government service, be subject to such conditions as to remuneration and otherwise, as the Administrator-General may determine.

(7) The commission shall hold meetings at such times and places as may be determined by the chairman from time to time.

(8) (a) The majority of the members of the commission who shall include the chairman shall form a quorum for a meeting of the commission.

(b) A decision of the majority of the members of the commission present at any meeting thereof shall constitute a decision of the commission: Provided that in the event of an equality of votes the chairman shall, in addition to his deliberative vote, have a casting vote.

(9) The administrative functions connected with the functions of the commission shall be performed by officers in the government service made available for such purpose by the Secretary of Transport. ”.

5.(1) The following section is hereby substituted for section 4 of the Act:

"Establishment and constitution of Road Transportation Board of South West Africa.

4.(1) There is hereby established a road transportation board to be called the Road Transportation Board of South West Africa.

(2) The board shall consist of a chairman and two other members appointed by the Administrator-General who shall be persons who possess wide experience of, and have shown ability in, transport, industrial, commercial or financial matters or in the conduct of public affairs and who are not members of the commission.

(3) (a) A member of the board who is full-time in the government service shall hold office during the Administrator-General's pleasure, and any other member of the board shall be appointed for a period of two years, and shall, subject to the provisions of this Act, hold office on such conditions as to remuneration and otherwise, as the Administrator-General may determine when such member is appointed.

(b) Different periods or conditions may be determined under paragraph (a) in respect of different members of the board.

(4) When a member of the board vacates his office or is removed therefrom or is temporarily unable to perform his functions as such, the Administrator-General may appoint, subject to the provisions of section 5, any person whom he considers suitable, to act in place of such member for a period, not exceeding 12 months, and any such appointment shall, in the case of a person who is not full-time in the government service, be subject to such conditions as to remuneration and otherwise, as the Administrator-General may determine.

(5) When a member of the board has recused himself in any particular matter, the Administrator-General may appoint, subject to the provisions of section 5, any person whom he considers suitable, to act with regard to that particular matter in place of such member, and any such appointment shall, in the case of a person who is not full-time in the government service, be subject to such conditions as to remuneration and otherwise, as the Administrator-General may determine.

(6) A person whose period of office as member of the board has expired shall be re-eligible for appointment. ”.

(2) A person who was a member of the Local Road Transportation Board, Windhoek, on the date immediately before the commencement of this Proclamation shall be deemed to have been appointed under section 4 of the Act, as amended by subsection (1) of this section, as a member of the Road Transportation Board of South West Africa as if the provisions of subsection (1) were in operation on the date on which he has been appointed as member of the said Transportation Board.

Amendment of section 5 of Act 74 of 1977

6. Section 5 of the Act is hereby amended –

(2) Different dates may be determined under subsection (1) in respect of different provisions of this Proclamation.

(3) A reference in this Proclamation to the commencement thereof shall be construed as a reference to the date determined accordingly.
