2. The following regulation is hereby substituted for regulation 68:

"68. TARIFFS:

All consumers shall pay the applicable tariffs set out in Annexure A: Provided that the owner of a premises where water supply is available, but not made use of, or the owner of any premises, with or without improvements, which can reasonably be connected to the Council's main, shall pay the lowest charge stipulated in paragraph 1 of Annexure A. "

3. Annexure A is hereby amended by the substitution for paragraph 1 of the following paragraph:

"1. BASIC CHARGE:

Each consumer shall pay, in addition to any other tariff payable in terms of any other paragraph of this Annexure, the following basic charge to the Council whether water was consumed or not, determined according to the diameter of the meter inlet:

Diameter of meter inlet	Charge per month
15mm	R 7,25
20mm	R 8,20
25mm	R 14,50
40mm	R 39,00
50mm	R 40,85
80mm	R 48,15
100mm	R 61,70
150mm and bigger	R108,90".

2. Regulasie 68 word hierby deur die volgende regulasie vervang:

"68. TARIWE:

Alle verbruikers moet die toepaslike tariewe vervat in Aanhangsel A betaal: Met dien verstande dat die eienaar van 'n perseel waar waterlewering beskikbaar is, maar nie gebruik word nie, of die eienaar van 'n perseel, met of sonder verbeterings daarop, wat by die Raad se hoofleiding redelikerwys aangesluit kan word, die laagste heffing in paragraaf (I) van Aanhangsel A uiteengesit, betaal. "

3. Aanhangsel A word hierby gewysig deur paragraaf 1 deur die volgende paragraaf te vervang:

"1. BASIESE HEFFING:

Benewens enige tarief wat ingevolge enige ander paragraaf van hierdie Aanhangsel betaalbaar is, betaal elke verbruiker die volgende basiese heffing aan die Raad of water verbruik is al dan nie, bepaal volgens die diameter van die inlaat van die meter:
