AMENDMENT OF THE RULES OF COURT

WYSIGING VAN REËLS VAN DIE HOF

The Administrator-General has under subsection (5) of section 25 of the Magistrates' Courts Act, 1944 (Act 32 of 1944), confirmed the amendment made by the Rules Board under subsection (3) of the said section 25 to the Rules of Court promulgated under Government Notice R. 1108 of 1968 and which is set out in the Schedule. The said amendment shall come into operation on 1 January 1990.
