LAND SURVEY ACT, 1927: AMENDMENT  
OF LAND SURVEY ACT REGULATIONS

Die Administrateur-generaal het kragtens artikel 8 van die Opmetingswet, 1927 (Wet 9 van 1927), die Opmetingswetregulasies uitgevaardig by Goewermentskennisgewing R. 1814 van 1962, met ingang van 1 Junie 1990, verder gewysig soos in die Bylae uiteengesit.

The Administrator-General has under section 8 of the Land Survey Act, 1927 (Act 9 of 1927), with effect from 1 June 1990, further amended the Land Survey Act Regulations promulgated under Government Notice R. 1814 of 1962 as set out in the Schedule.
