Beskrywing van grondgebied:

2. Prospective applicants must take note that –

(a) the minimum standards and requirements to which an applicant's proposed scheme to prospect upon such land, as contemplated in subparagraph (i) of section 60(8)(a) of the said Ordinance, must comply; and

(b) the particulars of the various defined portions of the area of land referred to in the Schedule,

are obtainable from the Mining Commissioner.

3. Applications must be lodged with the Mining Commissioner, Private Bag 13195, Windhoek, not later than three months from the date of publication of this notice.

Description of area of land:

The area of land extending for a distance of approximately three kilometres parallel to the northern bank of the Orange River, and situated between the eastern boundary of Diamond Area 1 and the eastern boundary of the territory of South West Africa, being the common boundary of the said territory and the Republic of South Africa.
