**PROPOSAL THAT A PORTION OF DISTRICT ROAD 1434
BE DEVIATED AND THAT THE CLASSIFICATION OF A
PORTION OF FARM ROAD 1437 BE CHANGED:
DISTRICT OF WINDHOEK**

In terms of section 20(1) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Permanent Secretary: Works, Transport and Communication proposes that, in the district of Windhoek -

- (a) the portion of district road 1434 described in paragraph (a) of Schedule I and shown on sketch-map P1490 by the symbols A-B be deviated, from the route so described and shown, to the route described in paragraph (b) of the said Schedule and shown on sketch-map P1490 by the symbols A-C; and
- (b) the classification of the portion of farm road 1437 described in Schedule II and shown on sketch-map P1490 by the symbols B-C be changed to district road (number 1434).

A copy of this notice and the said sketch-map, being a sketch-map of the area concerned on which the roads to which the proposal refers and other proclaimed, minor and private roads in that area are shown, shall for the full period of thirty days mentioned below, lie open to inspection at the offices of the Permanent Secretary: Works, Transport and Communication, Windhoek, and the Roads Superintendent, Windhoek, during normal office hours.

Every person having any objection to the above-mentioned proposal is hereby commanded to lodge his or her objection in writing, with the grounds upon which it is based clearly and specifically therein stated, with the Senior Control Officer (Section Proclamation) of the Department of Transport, Private Bag 12005, Ausspannplatz, 9000, within a period of thirty days from the date of publication of this notice.

- (a) From a point (A on sketch-map P1490) on district road 1434 on the farm Otjikundua 155 generally north-north-westwards across the said farm and the farm Hummelshain 154 to a point (B on sketch-map P1490) at the junction with the said district road and farm road 1437 on the last-mentioned farm.
- (b) From a point (A on sketch-map P1490) on district road 1434 on the farm Otjikundua 155 generally northwards and more and more north-north-westwards across the said farm and the farm Hummelshain 154 to a point (C on sketch-map P1490) on farm road 1437 on the last-mentioned farm.

From a point (B on sketch-map P1490) on district road 1434 on the farm Hummelshain 154 generally eastwards across the said farm to a point (C on sketch-map P1490) on the said farm.

It is hereby made known -

- (a) in terms of section 20(1) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that the Permanent Secretary: Works, Transport and Communication proposes that -
 - (i) in the districts of Maltahöhe and Mariental, the road described as main road 34 in Schedule II to Proclamation 36 of 1953, new portions and extensions of which are described in Schedules II and III to Proclamation 11 of 1959 and Schedule III to Proclamation 40 of 1961, be closed as shown on sketch-map P1477 by the symbols A-B-C-D-E-F-G-H-J-K-L-M-N-O-P-O-R-S-T-U-V-V1-W-W1-X-Y-Z-Z1; and
 - (ii) in the district of Mariental, a district road (number 1105) be proclaimed as described in the Schedule and shown on sketch-map P1477 by the symbols Y-Z; and

- (b) for general information that it will be proposed to the President to decrease under section 3(4)(aA) of the said Ordinance the width of the road reserve of the road referred to in paragraph (a)(ii) to thirty metres.
