**ELECTORAL ACT, 1992: BY-ELECTION FOR THE KABE
CONSTITUENCY OF THE CAPRIVI REGION: PUBLICATION
OF CANDIDATES, POLLING DAYS AND HOURS
AND POLLING STATIONS**

Under paragraph (b) of section 64(5) of the Electoral Act, 1992 (Act 24 of 1992), it is hereby made known -

- (a) that a poll shall be taken on 23 June 1993 and 24 June 1993, which poll shall commence at 07:00 on every day and shall close at 21:00 on every day, for the election of a member of the Caprivi Regional Council for the Kabe Constituency;
- (b) that each person whose names, registration number and residential address appears in Column 1 of the Schedule hereto has in terms of section 64(1) of the said Act been declared to be duly nominated in respect of the Kabe Constituency and that such person has been nominated by the political party indicated opposite his name in Column 1;
- (c) that, in terms of the provisions of section 73, polling stations have been established in the constituency in question at the places mentioned in Column 2 of the said Schedule.
