ROAD CARRIER PERMITS

1. Hot heavy furnace oil for use in oil firing burners of premix plants serving construction sites and which must be conveyed at a temperature of between 100 and 130 degrees Celsius —
- (a) From the nearest refinery or depot situated within Namibia direct to plants serving construction sites situated within Namibia which are not served by the rail services of the S.A. Transport Services;
 - (b) From a place on the Namibia/Republic of South Africa border at Nakop, C.R. Swart bridge or Noordoewer *en route* from the nearest refinery situated within the Republic of South Africa where the hot liquid concerned is available direct to plants serving construction sites situated within Namibia which are not served by the rail services of the S.A. Transport Services;
 - (c) From the nearest refinery or depot situated within Namibia direct to a place on the Namibia/Republic of South Africa border at Nakop, C.R. Swart bridge or Noordoewer *en route* to plants serving construction sites situated within the Republic of South Africa which are not served by the rail services of the S.A. Transport Services; or
 - (d) From a place on the Namibia/Republic of South Africa border at Nakop, C.R. Swart bridge or Noordoewer *en route* from the nearest refinery situated within the Republic of South Africa where the hot liquid concerned is available direct to a place on the Namibia/Republic of South Africa border at Nakop, C.R. Swart bridge or Noordoewer *en route* to plants serving construction sites situated within the Republic of South Africa which are not served by the rail services of the S.A. Transport Services.

"B"

1. Polymer bitumen, rubber bitumen and derivatives thereof (all in bulk liquid form) which of necessity must be conveyed at a temperature of not less than 180°C (one hundred and eighty) degrees Celsius — Between points within Namibia.
- (a) for the purpose of transferring to another spraying vehicle for the purpose of spraying, immediately upon completion of the transfer of the hot liquid concerned, by means of the last mentioned vehicle;
 - (b) for the purpose of transferring to a bulk storage tank at road construction sites or at the premix asphalt or emulsifying plant serving such construction sites, if such plants are not served by private rail sidings.

"C"

Hot bituminous tar products and derivatives thereof (in bulk liquid form) — From points on the Namibia/Republic of South Africa border direct to construction sites, plants or depots situated within Namibia as well as to points on the Namibia/Republic of South Africa border *en route* to construction sites or plants to be supplied, situated outside Namibia.
