REGIONAL COUNCILS ACT, 1992:  
BY-ELECTION IN OMUPUNDJA CONSTITUENCY:  
DETERMINATION OF DAY AND PLACE FOR SUBMISSION  
OF NOMINATIONS OF CANDIDATES AND POLLING DAY  
AND NOTIFICATION OF NAME OF RETURNING OFFICER

Under the powers vested in me by subsection (1) of section 50 of the Electoral Act, 1992 (Act 24 of 1992), it is hereby made known -

- (a) that I have determined, in terms of that subsection -
- (i) Wednesday, 31 August 1994, as the day on which a public sitting shall be held in respect of the Omupundja constituency for the submission of nominations of candidates for election as a member of the regional council for that constituency;
  - (ii) that the said public sitting shall be held at the Omupundja Junior Primary School, Omupundja, from 09h00 until 11h00 on that day;
  - (iii) that, if a poll becomes necessary in the said constituency for the reason that more than one person shall have been duly nominated at the close of the said sitting, the poll shall be taken on 30 September 1994, commencing at 07h00 and closing at 21h00 on that day;
- (b) Mr. J. Rukambe, Directorate of Elections, Windhoek, has been appointed in terms of section 51 of the said Act as returning officer at the election.
