DEVIATION OF A PORTION OF MAIN ROAD 56: DISTRICT OF GOBABIS

In terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Minister has under section 22(1)(c) of

the said Ordinance, in the district of Gobabis, deviated the portion of main road 56 described in paragraph (a) of the Schedule and shown on sketch-map P1537 by the symbols A-B-C-D-E, from the route so described and shown, to the route described in paragraph (b) of the said Schedule and shown on sketch-map P1537 by the symbols A-F-E.

The said sketch-map shall at all times lie open to inspection at the Office of the Permanent Secretary: Works, Transport and Communication, Windhoek, during normal office hours.

SCHEDULE

- (a) From a point (A on sketch-map P1537) on Gobabis Townlands 114 generally northwards across the said Townlands to a point (B on sketch-map P1537) on the said Townlands; thence generally north-eastwards across the said Townlands and the farm Wendelstein 1026 to a point (C on sketch-map P1537) on the last-mentioned farm; thence generally north-north-westwards across the last-mentioned farm and the farm Portion A of Ohlshenhagen 174 to a point (D on sketch-map P1537) on the last-mentioned farm; thence generally north-north-westwards across the last-mentioned farm and the farm Wilhelmshöhe 176 to a point (E on sketch-map P1537) on the last-mentioned farm.
- (b) From a point (A on sketch-map P1537) on Gobabis Townlands 114 generally north-north-westwards across the said Townlands to a point (F on sketch-map P1537) on the said Townlands; thence generally northwards across the said Townlands and the farms Wendelstein 1026, Portion A of Ohlshenhagen 174 and Wilhelmshöhe 176 to a point (E on sketch-map P1537) on the last-mentioned farm.

**DEVIATION OF A PORTION OF DISTRICT ROAD 1901
AND AMENDMENT OF THE WIDTH OF THE ROAD
RESERVE OF A PORTION OF DISTRICT ROAD 1901:
DISTRICT OF SWAKOPMUND**

It is hereby made known -

- (a) in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that the Minister has under section 22(1)(c) of the said Ordinance, in the district of Swakopmund, deviated the portion of district road 1901 described in paragraph (a) of the Schedule and shown on sketch-map

P1517 by the symbols C-F, from the route so described and shown, to the route described in paragraph (b) of the Schedule and shown on sketch-map P1517 by the symbols A-B-C;

- (b) in terms of section 3(4)(b) of the said Ordinance that the Minister has under section 3(4)(aA) of the said Ordinance, decreased to thirty metres the width of the road reserve of a portion of district road 1901 as shown on sketch-map P1517 by the symbols A-B-C.

The said sketch-map shall at all times lie open to inspection at the office of the Permanent Secretary: Works, Transport and Communication, Windhoek, during normal office hours.
