No. 121 1996

AMENDMENT OF REGULATIONS UNDER THE CASINO'S AND GAMBLING HOUSES ACT, 1994

The Minister of Environment and Tourism has, under section 54 of the Casino's and Gambling Houses Act, 1994 (Act 32 of 1994), made the regulations set out in the Schedule:

SCHEDULE

1. In this Schedule "the Regulations" means the regulations under the Casino's and Gambling Houses Act, 1994 (Act 32 of 1994) promulgated by Government Notice 231 of 2 December 1994, as amended by Government Notice 84 of 15 May 1995 and Government Notice 136 of 11 August 1995.

2. Regulation 1 of the Regulations is amended by the insertion before the definition of "secretary" of the following definition:

"gambling area" means that part or parts of a casino or gambling house where gambling machines or other gambling devices are placed and where gambling activities are conducted."

3. Regulation 3 of the Regulations is amended by the substitution for subparagraph (ii) of paragraph (b) of subregulation (2) of the following subparagraph:

"(ii) the area or areas comprising the gambling area; and"

4. Regulation 7 of the Regulations is amended by the substitution for subparagraph (ii) of paragraph (b) of subregulation (2) of the following subregulation:

"(ii) the area or areas comprising the gambling area; and"

5. Regulation 17 of the Regulations is amended by the addition of the following subregulation:

"(4) Every holder of a gambling house licence who conducts a retail liquor business shall, simultaneously with the payment referred to in subregulation (2), submit to the secretary a certified copy of the current liquor licence held by such holder in respect of such business or furnish to the secretary such other proof, as the secretary may require, that the annual fee in respect of such liquor licence has been paid in respect of the year in question."
