Notice is hereby given under section 3(1) of the Post and Telecommunications Act, 1922 (Act 19 of 1992), that the Board of Directors has-

- a) determined that the surface and airmail rates to be demanded or received in respect of postal services as well as parcels rendered by the Company with regard to postal articles destined for delivery in any country other than Namibia shall with effect from 1 April 1997 be as set out in the Schedule; and
- b) repealed General Notice 32 of 1996 with effect from 1 April 1997.

No airmail service for parcels to South Africa.

Namibia Post introduced an overnight road transport distribution system to South Africa which means that no letters or parcels are conveyed via air transport to South Africa anymore. This was necessitated to eliminate mail violation as far as possible and to decrease transit times - the overnight road service is quicker than next day passenger airplane service. With our new transport system the mail stays only in possession of the two Postal Administrations.
