REGULATIONS RELATING TO FEES OR ALLOWANCES PAYABLE TO OR BY THE HEALTH INSPECTORS BOARD UNDER THE ALLIED HEALTH SERVICES PROFESSIONS ACT, 1993

The Minister of Health and Social Services has, upon the recommendation of the Health Inspectors Board, under section 45(1) of the Allied Health Services Professions Act, 1993 (Act 20 of 1993), made the regulations set out in the Schedule.

SCHEDULE

1. In these regulations, unless the context otherwise indicates, an expression defined in the Allied Health Services Professions Act, 1993 (Act 20 of 1993), has a corresponding meaning; and

"section" means a section of that Act.

2. The fees payable to the Health Inspectors Board are as follows:

THE ALLIED HEALTH SERVICES PROFESSIONS ACT, 1993: THE HEALTH INSPECTORS BOARD: LEVYING OF ANNUAL FEES ON REGISTERED PERSONS

The Minister of Health and Social Services has, upon the recommendation of the Health Inspectors Board, under section 46(1) of the Allied Health Services Professions Act, 1993 (Act 20 of 1993), determined the fees to be paid annually by persons registered with that Board as set out in the Schedule.

SCHEDULE

1. The fees to be paid annually by persons registered with the Health Inspectors Board under the Allied Health Services Professions Act, 1993 (Act 20 of 1993), are as follows:

2. The fees determined by the Minister as set out in paragraph 1 shall be paid -

| (a) | to the Health Inspectors Board; and |
| (b) | annually in advance before the first day of July of the year in respect of which such annual fees are payable. |

3. An annual fee referred to in paragraph 1 which is paid after the date of payment determined by paragraph 2, shall be increased by an amount equal to one-tenth of the amount of the annual fee payable in respect of every month that such annual fee is paid after the date for payment so determined.

4. An annual fee referred to in paragraph 2 which becomes payable at the date of registration of a Health Inspector, Environmental Health Assistant or Student Health Inspector, as the case may be, shall, if such date of registration falls after the first day of July of the year in respect of which such annual fee is payable, be decreased by an amount equal to one-twelfth of the amount of the annual fee payable in respect of every month that such registration takes place after such first day of July.

5. For the purposes of paragraphs 3 and 4, a part of a month shall be deemed to be a full month.
