It is hereby made known -

- (a) in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that the Minister has, in the district of Lüderitz under section 22(1)(b) of the said Ordinance declared the road described in the Schedule and shown on sketch-map P2003 by the symbols A1-B-C-C1 to be a proclaimed road.
- (b) in terms of section 23(3) of the said Ordinance that the Minister has under section 23(1)(c) of the said Ordinance declared the road referred to in paragraph (a) to be a district road (number 706).
- (c) in terms of section 3(4)(b) of the said Ordinance that the Minister has under section 3(4)(aA) of the said Ordinance, in the district of Lüderitz, decreased the width of the road reserve of district road 706 described in the Schedule and shown on sketch-map P2003 by the symbols A1-B-C-C1, to thirty metres.

The said sketch-map shall at all times lie open to inspection at the office of the Permanent Secretary: Works, Transport and Communication, Windhoek, during normal office hours.

generally north-westwards across the said land to a point (C1 on sketch-map P2003) on the common boundary of the said land and the Agate Beach Area.
