2. Regulation 2 of the Regulations is hereby amended by the substitution for the definition of "airport" of the following definition:

"airport" means the Eros Airport (Windhoek Regional Airport), the Keetmanshoop Airport, the Walvis Bay Airport and the Hosea Kutako International Airport (Windhoek International Airport), as the case may be; and "State airport" has a corresponding meaning.
