#### CLOSING OF A PORTION OF FARM ROAD 1437: DISTRICT OF WINDHOEK: KHOMAS REGION

In terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), it is hereby made known that the Minister has under section 22(1)(c) of the said Ordinance, in the district of Windhoek, closed a portion of farm road 1437 described in the Schedule and shown on sketch-map P2024 by the symbols A-B-C.
