It is hereby made known for general information that the number of a portion of farm road 2158 described in the Schedule and shown on sketch-map P2034 by the symbols A-B-C-D, has been changed to farm road 2191.

SCHEDULE

From a point (A on sketch-map P2034) at the junction with district road 2180 on the farm Portion A of Okaruheke 37 generally south-eastwards and more and more eastwards across the said farm and the farms Omongonoua 38 and Guldenboden 280 to a point (B on sketch-map P2034) on the last-mentioned farm; thence generally east-north-eastwards across the last-mentioned farm to a point (C on sketch-map P2034) on the last-mentioned farm; thence generally east-south-eastwards across the last-mentioned farm to a point (D on sketch-map P2034) on the common boundary of the last-mentioned farm and the farm Ombujomenge 39.
