PROCLAMATION OF DISTRICT ROADS (NUMBERS 3830, 3831 AND 3832)  
AND THE CLOSING OF A PORTION OF DISTRICT ROAD 3301: DISTRICT OF  
OTJINENE: OMAHEKE REGION

It is hereby made known -

- (a) in terms of section 22(2) of the Roads Ordinance, 1972 (Ordinance 17 of 1972), that the Minister has, in the district of Otjinene
- (i) under section 22(1)(b) of the said Ordinance declared the roads described in Schedules I, II and III and shown on sketch-map P2073 by the symbols A-B-C-D-E-F-G, J-L-M-N-O-P-Q-G-H and M-P respectively, to be proclaimed roads.
  - (ii) under section 22(1)(c) of the said Ordinance closed a portion of district road 3301 described in Schedule IV and shown on sketch-map P2073 by the symbols A-J-K.
- (b) in terms of section 23(3) of the said Ordinance that the Minister has under section 23(1)(c) of the said Ordinance declared the roads referred to in paragraph (a)(i) to be district roads (numbers 3830, 3831 and 3832).

The said sketch-map shall at all times lie open to inspection at the office of the Permanent Secretary: Works, Transport and Communication, Windhoek, during normal office hours.

### SCHEDULE I

From a point (A on sketch-map P2073) at the junction with district road 3301 at the Veterinary Gate generally eastwards and more and more east-south-eastwards along the Epukuro Omuramba to a point (B on sketch-map P2073); thence generally eastwards and more and more east-north-eastwards along the Epukuro Omuramba to a point (C on sketch-map P2073); thence generally east-north-eastwards and more and more north-north-eastwards along the Epukuro Omuramba to a point (D on sketch-map P2073); thence generally north-eastwards and more and more east-north-eastwards along the Epukuro Omuramba to a point (E on sketch-map P2073); thence generally eastwards and more and more northwards along the Epukuro Omuramba to a point (F on sketch-map P2073); thence generally north-eastwards and more and more north-north-eastwards along the Epukuro Omuramba to a point (G on sketch-map P2073) at the junction with the road described in Schedule II.

### SCHEDULE II

From a point (J on sketch-map P2073) at the junction with district road 3806 generally eastwards and more and more east-north-eastwards along the Eiseb Omuramba to a point (L on sketch-map P2073); thence generally eastwards along the Eiseb Omuramba to a point (M on sketch-map P2073) at the junction with the road described in Schedule III; thence generally east-south-eastwards along the Eiseb Omuramba to a point (N on sketch-map P2073); thence generally south-eastwards and more and more north-eastwards to a point (O on sketch-map P2073); thence generally eastwards along the Eiseb Omuramba to a point (Q on sketch-map P2073); thence generally southwards to a point (G on sketch-map P2073) at the junction with the road described in Schedule I; thence generally southwards across the farms Farm 885, Farm 886, Farm 899, Farm 900 and Farm 864 to a point (H on sketch-map P2073) at the junction with district road 3814 on the last-mentioned farm.

### SCHEDULE III

From a point (M on sketch-map P2073) at the junction with the road described in Schedule II generally north-north-eastwards to a point (P on sketch-map P2073) at the Veterinary Gate.

### SCHEDULE IV

From a point (A on sketch-map P2073) at the junction with the road described in Schedule I at the Veterinary Gate generally north-north-westwards and more and more northwards to a point (J on sketch-map P2073) at the junction with district road 3806 and the road described in Schedule II; thence generally northwards to a point (K on sketch-map P2073) on the common boundary of the districts of Otjinene and Tsumkwe.

**DEVIATION OF A PORTION OF DISTRICT ROAD 3509: DISTRICT OF KATIMA MULILO: CAPRIVI REGION**
