KARIBIB AND OSHIKANGO CONSTITUENCIES: ELECTORAL ACT, 1992**

In terms of section 21(b) of the Electoral Act, 1992 (Act No. 24 of 1992), as applied by section 28 of the said Act, it is hereby notified that copies of the provisional supplementary national voter's register for the Karibib Constituency in the Erongo Region and Oshikango Constituency in the Ohangwena Region, prepared in terms of section 21(a), shall be available for inspection by the public at the Office of the Electoral Commission of Namibia, Old Bank of Namibia, Daniel Munamava Street, Windhoek, and at the Magistrate's Office, Karibib Constituency and at the Odibo St. Mary's Mission in the Ohangwena Region, during office hours.

The period within which objections may be made of the names of voters appearing on the said register shall be from 30 November 2001 to 14 December 2001.
