APPOINTMENT OF NGOMA AS A PLACE FOR HOLDING A COURT AND PRESCRIPTION OF THE LOCAL LIMITS OF SUCH COURT: MAGISTRATES' COURTS ACT, 1944

Under section 2(1)(h) of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), I -

- (a) appoint Ngoma, within the district of Katima Mulilo and the district division Rundu, as a place for the holding of a court for the said district and district division; and
- (b) prescribe the local limits of the police stations at Impalila Island and Ngoma as the local limits within which the court referred to in paragraph (a) exercises jurisdiction.

**REDEFINITION OF THE LOCAL LIMITS OF DISTRICTS
AND CREATION OF NEW DISTRICTS IN NAMIBIA AMENDMENT:
MAGISTRATES' COURTS ACT, 1944**

Under section 2 of the Magistrates' Courts Act, 1944 (Act No. 32 of 1944), I amend the Schedule to Government Notice No. 23 of 17 February 1994 as amended by Government Notice No. 122 of 1997, Government Notice No. 22 of 1999 and Government Notice No. 177 of 15 July 2000 -

- (a) by inserting, opposite the district Katima Mulilo mentioned in column 3,
 - (i) in column 5, the expression "Ngoma"; and
 - (ii) in column 6, the expression "PP"; and
- (b) by adding the following Annexure:

"ANNEXURE PP: NGOMA

Local limits for the periodical court at Ngoma in the district of Katima Mulilo:

That area served by the Namibian Police at the police stations of Impalila Island and Ngoma."
