**GENERAL ELECTION FOR REGIONAL COUNCILS: DETERMINATION OF
DAYS AND PLACES FOR SUBMISSION OF NOMINATIONS OF CANDIDATES
AND POLLING DAYS FOR ELECTIONS AND NOTIFICATION OF NAMES OF
RETURNING OFFICERS**

Under the powers vested in me by subsection (1) of section 50 of the Electoral Act, 1992 (Act No. 24 of 1992), I hereby make known that -

- (a) I have under that subsection determined -
- (i) Friday, 22 October 2004, as the day on which a public sitting shall be held in each of the constituencies mentioned in the second column of the Schedule hereto, for the submission of the nomination of candidates for election as a member of the regional council for the constituency in question;
 - (ii) that the public sitting shall be held from 09:00 until 11:00 on that day at the place mentioned in the third column of the Schedule hereto opposite the constituency in question;
 - (iii) that, if a poll becomes necessary in any of the constituencies mentioned in the Schedule hereto for the reason that more than one person had, at the close of the public sitting, been duly nominated, the poll shall be taken on Monday, 29 November 2004, and Tuesday, 30 November 2004;
- (b) the person whose name is specified in the fourth column of the Schedule hereto, opposite the constituency mentioned in the third column of that Schedule, has been appointed in terms of section 51 of the Electoral Act, 1992, as returning officer for the election in that constituency.
