In terms of Sub-Article (8) of Article 32 of the Namibian Constitution, I announce that I have under the powers vested in me by Sub-Article (3)(h) of that Article -

- (a) conferred the honour of national hero status on the late Reverend Markus Kooper; and
- (b) directed that a State funeral be held in honour of the late Reverend Markus Kooper.

**ANNOUNCEMENT IN TERMS OF ARTICLE 32(8) OF THE NAMIBIAN
CONSTITUTION OF CERTAIN APPOINTMENTS**

In terms of Sub-Article (8) of Article 32 of the Namibian Constitution, I announce that I have under the powers vested in me -

- (a) by Sub-Article (3)(i)(bb) of that Article, appointed Stefanus Orateng Mogotsi as Deputy-Minister of Works, Transport and Communication with effect from 21 October 2005;
- (b) by Sub-Article (4)(a)(aa) of that Article read with Article 82 of the Namibian Constitution, appointed, on the recommendation of the Judicial Service Commission -
 - (i) Mr Justice Mahomed Jajbhay as an acting Judge of the High Court of Namibia for the period 11 to 12 April 2005;
 - (ii) Mr Louw Carl Muller -
 - (aa) as an acting Judge of the High Court of Namibia for the period 1 October 2005 to 30 November 2005; and
 - (bb) as a Judge of the High Court of Namibia with effect from 1 December 2005; and
 - (ii) Mr Justice Johannes Dawid Gerhardus Maritz as a Judge of the Supreme Court of Namibia with effect from 1 January 2006.
