**LEVIES UNDER THE MEAT INDUSTRY ACT, 1981**

Under section 17(1) of the Meat Industry Act, 1981 (Act No. 12 of 1981), and on the recommendation of the Meat Board of Namibia, I impose, with effect from 1 July 2007, the special levies set out in the Schedule below.

## SCHEDULE

### 1. Definitions

In this notice, unless the context indicates otherwise, a word or expression to which a meaning is assigned in the Act bears that meaning, and -

“foot and mouth disease veterinary fixture” means a fence the starting point of which is at Palgrave Point situated on the west coast of Namibia from whence it continues in a generally easterly direction up to a point, being on a latitude of 20 degrees, on the border common between Namibia and Botswana; and

“the Act” means the Meat Industry Act, 1981 (Act No. 12 of 1981).

### 2. Special Levies

The applicable special levies, set out in the Table below, shall be imposed upon producers located in that part of Namibia which lies to the south of the foot and mouth disease veterinary fixture who, during the period 1 July 2007 to 30 May 2012-

- (a) slaughter any cattle, sheep or goats within;
- (b) export cattle, sheep or goats from;
- (c) import cattle, sheep or goats which are to be kept on any premises within that part of Namibia.

**TABLE OF SPECIAL LEVIES**

Controlled Products	Special Levies Imposed
<b>Cattle</b>	N\$16.45 per head
<b>Sheep</b>	N\$3,29 per head
<b>Goats</b>	N\$3,29 per head

### 3. Purpose of Special Levies

The special levies, referred to in paragraph 2 of this Schedule shall be utilized for purposes of improving, for the benefit of producers located in that part of Namibia which lies to the north of the foot and mouth disease veterinary fixture, access to livestock markets in respect of cattle, sheep and goats.

### 4. Payment of Special Levies

The special levies referred to in paragraph 2 of this Schedule shall be payable by all producers contemplated in that paragraph, but not by producers who are natural persons or *bona fide* farmers who slaughter cattle, sheep or goats for their own use.

**Note:** The special levies referred to in paragraph 2 do not include VAT.
