Under the powers vested in me by section 50(1)(b) of the Electoral Act, 1992 (Act No. 24 of 1992), I make known that, in respect of the general election –

- (a) for the election of a President, pursuant to Article 28 of the Namibian Constitution, read with section 49(1)(a)(i) of that Act; and
- (b) for the election of members of the National Assembly, pursuant to Article 46 of the Namibian Constitution, read with section 49(1)(b)(i) of that Act,

I have determined Friday, 27 November 2009 and Saturday, 28 November 2009 as the days upon which a poll shall take place, from the hours 07h00 to 21h00, for the election of a President as well as for the election of members of the National Assembly.

SUBMISSION OF NOMINATIONS OF CANDIDATES

Under the powers vested in me by section 50(1)(a) of the Electoral Act, 1992 (Act No. 24 of 1992), I make known that, in respect of the general election to be held on 27 November 2009 and 28 November 2009 –

- (a) for the election of a President, pursuant to Article 28 of the Namibian Constitution, read with sections 49(1)(a)(i), 55(1) and 56 of that Act, I have determined 19 October 2009 as the date on which the submission of nominations of candidates for election to the office of the President shall take place at a public sitting to be held by the Chairperson of the Electoral Commission at the High Court, Windhoek from 9h00 until 11h00; and
- (b) for the election of members of the National Assembly, pursuant to Article 46 of the Namibian Constitution, read with sections 49(1)(b)(i) and 59(1) of that Act, I have determined 19 October 2009 as the last day on which political parties that intend to participate in the election for members of the National Assembly shall, not later than 11h00 on that day, submit a written list of candidates nominated with a view to the filling of any seats in the National Assembly to which such political parties may become entitled, to the Electoral Commission at the office of the Director of Elections, Directorate of Elections, 11 Goethe Street, Windhoek.
